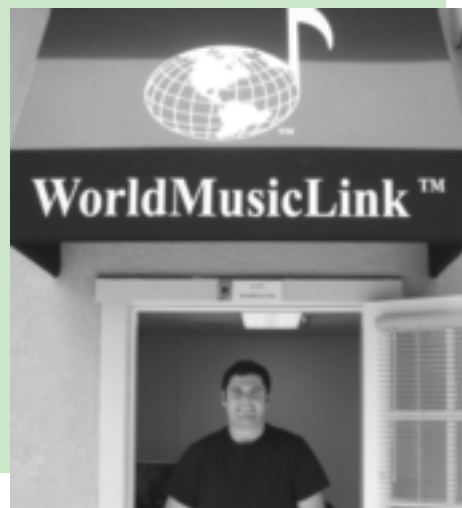
Reagan Pollack '07 cofounded WorldMusicLink in November 2008. "I had been a member of a band for many years," says Pollack. "I was aware of the problems that musicians encounter in gaining exposure with the right professionals. I knew there was a disconnect in the industry, and I viewed the problem as an opportunity."

Pollack estimates that there are 5 million indie bands in the U.S. and 150,000 music industry companies. WorldMusicLink uses the Internet's reach to connect music talent with record labels, managers, and promoters. The company offers two types of accounts, one that is free and supported by ads and one that is supported by subscriptions.

A musician or band fills out a profile on WorldMusicLink.com and uploads media content such as music, videos, and calendars. On the flip side, a promoter, who also fills out a profile, searches for new talent to sign and promote. "Without leaving the office, a record label can field appropriate bands without sifting through thousands of CDs," says Pollack. "Similarly, band members can locate a label that's seeking their sound and type."

According to Pollack, the global music industry is a \$45-billion-a-year business, including ancillary products such as concerts, recordings, and merchandise. "We would like to raise venture capital and expand our international user base. A record label from Africa should be able to find agents from the Netherlands and producers in Japan. Our goal is to put the 'world' into WorldMusicLink."

Pollack credits the company's initial success to its board of advisers, many of whom are connected to Babson: **Bob Jamieson '68**, former chair and CEO, RCA Music Group; **Ted Grossman, P '02**, senior lecturer, information systems; **Bob Caspe**, adjunct lecturer, marketing; **Glenn Kaplus, MBA '92**, adjunct lecturer, entrepreneurship; and **Kuljit Dharni**, MBA candidate and former director, IT architecture.
